# Weed Spraying Contract for Looe for 2016 season

#### **Scope of Works**

Before commencement of works, the Approved Contractor should provide to the Clerk of Looe Town Council:

- Copies of current Building and Public Liability insurance (to cover the 2016 spraying contract period)
- Copies of relevant Competence Certification (including Operator NPTC Certification)
- Copies of relevant Risk Assessments and Method Statements

In addition the Approved Contractor shall:

- Ensure that the "Approved for Use herbicides to be applied are COSHH assessed to be the most appropriate for the situation and to present the least risk to the health of the public, the environment and animals as well as to the operatives.
- Ensure compliance with the law by using correct vehicles with suitable portable stores when transporting chemicals and related equipment in compliance with The Carriage of Agrochemicals by Road: Guidance for the Agrochemicals Industry.
- Ensure that suitable and sufficient COSHH assessments are completed by competent persons before any pesticides are used.
- Ensure that, in the case of street weed spraying where there is a need to apply a pesticide directly onto an area with public access, that any operatives strictly follow the herbicides' instructions and the detailed advice of a properly trained advisor (BASIS qualified) to avoid putting people at risk.
- Ensure that all herbicide applications are made by controlled droplet applicators (CDA) to minimise the potential effect on the environment.


The Weed Spraying Contract is for two applications (1 in Spring 2016 and 1 in Autumn 2016) and is to cover all the pedestrian surfaces other than the highways itself (including gutters, edges and spot areas as applicable).

The Approved Contractor will execute the herbicide spraying of weeds on behalf of Looe Town Council consisting of those areas marked in green on the attached map (Appendix A), also known as Zone 2 areas, plus additionally:

- Barbican Road to Looe Bay Holiday Park
- Bass Hill
- Dawes Lane
- St George's Road
- Bay View Road
- Plaidy Park Road

Closing date for submissions of tender: **12noon Friday 26**<sup>th</sup> **February 2016.**
